Minutes of the Special Board Meeting of Thursday, August 17, 1978

CALL TO ORDER:

The special meeting of the Board of Trustees of Community College District No. 512 was called to order by Chairman Klussmann on Thursday, August 17, 1978, at 4:35 p.m., in the Board Room of the Administration Building, Algonquin and Roselle Roads.

## REPAIRS TO BUILDING A

Chairman Klussmann explained the special meeting of the Board of Trustees had been called to provide direction to the administration on bidding for repairs to Building A.

Member Dasher moved, Member Tomchek seconded, that the Board of Trustees direct the administration to obtain competitive bids for the purpose of making Building A safe at all entrances, so that all entrances can be used; after receiving competitive bids which meet with their specifications, they should accept the lowest bid and move expeditiously in the repair work.

Member Tomchek questioned if the lowest bid was accepted whether this might not take longer than another bid. It was agreed the motion indicated the lowest bid meeting specifications, or the lowest appropriate bid, and that the specifications could set a time limit.

Member Mariahazy asked why the motion was only for Building A. Member Dasher pointed out the other buildings are usable and the rush was to make Building A safe at all entrances.

Member Bone entered the meeting at 4:40 p.m.

President McGrath informed the Board the administration would bring back for Board review everything done in terms of bids received. He stated the administration would like to act for the safety of the college community.

Member Weber stated she had hoped this could be accomplished before classes started. Member Tomchek felt that with an active Building Committee and a competent administration, the administration could move on this.

Mr. Misic pointed out that according to Attorney Schwartz, the administration would not be able to award the bid without Board action.

Member Tomchek felt the Board's action at this meeting would give the administration the right to go ahead. The Board Members agreed they could approve the bid award after the fact.

Chairman Klussmann stated Dr. Perry had checked with the attorney to see that there would be no legal problems, and stated the attorney had told them to go ahead with the meeting.

President McGrath stated it was his understanding that this is an emergency.

For the benefit of Member Bone, Member Tomchek summarized the motion.
