ADVERTISEMENT FOR BIDS**

1.1 BID INFORMATION

- A. Sealed bids will be received by Harper College, on Monday, March 31st, 2025, at 11:00 A.M. Central Time for furnishing all necessary labor, equipment, and material for the Building I – Business & Social Sciences Building (BSSB) – BID REQUEST NO. Q01184 at Harper College at 1200 West. Algonquin road, Palatine, Illinois 60067.
- B. The Work consists of a new Business & Social Sciences Building and demolition of existing buildings I&J, located on the existing campus in Palatine, Illinois. Note: this project will be bid in multiple bid periods. This is bid period #1, the scope of work includes the build out of temporary space in the existing Building I, playground relocation, and the demolition of the existing Building J and the J-Theater.
- C. Lump sum bid proposals will be received for this project at the scheduled time of receipt of bids and will be publicly opened and read aloud.
- D. A Non-Mandatory Pre-Bid Meeting has been scheduled on Wednesday, February 26th 2025, at 1:00 P.M., at Harper College Palatine IL room W-219. Prospective bidders are encouraged to attend, which will also be attended by the Owner and Architect and CM, to review the scope of work and bidding requirements.
- E. Questions regarding the Bidding Documents shall be submitted to the Construction Manager and College via emails to Tim Lumpp (tlumpp@pepperconstruction.com) with a copy to Jewell Jackson (purchasing@harpercollege.edu). Replies will be issued to all bidders of record in the form of an Addendum. Questions received after Wednesday March 5th 2025, at 3:00 P.M. Central Time may not be answered.
- F. Bid security in the form of bid bond in an amount equal to ten percent (10.0%) of the aggregate of the Base Bid amount and all Alternate Bid amounts shall be submitted with the bid.
- G. Performance, Labor and Material Payment Bonds, and Certificate of Insurance will be required from the successful bidder.
- H. Bids shall be submitted in an opaque sealed envelope addressed to: Harper College, Purchasing Department, Room A217, 1200 West Algonquin Road, Palatine, Illinois 60067.
- I. No bid may be withdrawn for a period of ninety (90) days after the submission without the consent of the Board of Trustees.
- J. Harper College reserves the right to reject any or all bids or parts thereof, to waive any irregularities or informalities in bidding procedures, and to award the contract in a manner best serving the interest of the College.

- K. All bidders must comply with applicable Illinois Law requiring the payment of prevailing wages by all Contractors working on public works. Bidder must comply with the Illinois Statutory requirements regarding labor, including Equal Employment Opportunity Laws.
- L. Contractors shall pay not less than the prevailing rates of wages to all laborers, workmen, and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).
- M. Bidders shall comply with the Business Enterprise Program (BEP) Participation and Utilization Plan developed by Harper College. Bidders shall review all required BEP information in section '00 80 00 Enterprise Program Participation Utilization Plan' of this front end document, including the following BEP aspirational goals by Contract.
- Demolition Package: 10% BEP Utilization
 - General Trades Package: 10% BEP Utilization
 - Electrical Package: 5% BUP Utilization
- N. Any bid submitted unsealed, unsigned, fax transmission, email, or received subsequent to the aforementioned date and time, may be disqualified and returned to the bidder.
