

## 1.1 BID INFORMATION

- A. Sealed bids will be received by Harper College (Owner) on **March 27, 2025, until 11:00 AM** central time for the **Harper College 2025 Parking Lot & Asphalt Pavement Maintenance (project number Q01187)** located at 1200 West Algonquin Road, Palatine, Illinois 60067. Bids will be received in the Purchasing Department, Building A, Room A217 and will be opened publicly directly following the deadline for receipt of bids.
- B. The project includes (but is not limited to) the following:
  - 1. mobilization, site preparation, demolition, asphalt paving, pavement striping, concrete curb & gutter, and storm utility drainage.
- C. Harper College reserves the right to reject any or all bids or parts thereof, to waive any irregularities or informalities in bidding procedures and to award the contract in a manner best serving the interest of the College.
- D. Bidder must comply with the Illinois Statutory requirements regarding labor, including Equal Employment Opportunity Laws.
- E. Contractors shall pay not less than the prevailing rates of wages to all laborers, workmen and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).
- F. The successful bidder will enter into a Contract with the Owner in the form of an Agreement as provided in the Project Manual.

- K. Any bid submitted unsealed, unsigned, fax transmission, e-mail or received subsequent to the aforementioned date and time, may be disqualified and returned to the bidder.

- L. Bidders shall comply with the Business Enterprise Program: Participation and Utilization Plan developed by Harper College. There is a 20 percent aspirational goal on the contract.
