## Submit the Program Application with a Valid National League for Nursing (NLN) Pre-Admission RN Exam Score Report

- □ Submit your program application by going to the PTA web page at <a href="https://www.harpercollege.edu/academics/health/physical-therapist-assistant/admission.php">https://www.harpercollege.edu/academics/health/physical-therapist-assistant/admission.php</a> within the time frame indicated above.
- Your Harper College Application must already be on file and you must have participated in a program information meeting within the past year.
- You may also attach a valid copy of your **NLN Pre Admission RN Exam** results showing that all minimums have been satisfied.

<u>NLN Pre-Admission RN Exam Report</u> – Each of the minimum percentile scores must be satisfied on the same test:

Minimum Score	NLN Score Report
<b>Composite</b> : 60 <sup>th</sup> percentile or higher	
<b>Verbal</b> : 40 <sup>th</sup> percentile or higher	Once scores are posted, you will want to check the section entitled RN Program Applicants to find your results.
Science: 40 <sup>th</sup> percentile or higher	The Composite, Verbal, Math and Science percentile scores
Math: 40 <sup>th</sup> percentile or higher	are listed under the RN Percentile Rank.

- Scores from an NLN Pre-Admission RN Test are valid for three years. (Refer to the chart later in this document for detailed information regarding expiration dates.)
- For details on how to interpret your NLN score report, please refer to the program web site.
- Resources for test preparation include the <u>Review Guide for NLN-RN Pre-Entrance Exam, Third Edition</u> available at the Harper Store, online and through retail bookstores; a course offered through Harper's Continuing Education division titled: NLN Pre-Entrance Exam Preparation; McGraw-Hill's NLN PAX-RN Prep app, Magoosh.com, PrepSTEP, formally the Learning Express Library (check the Harper College library for information), study guides for the ACT or SAT, youtube for vocabulary, and the Tutoring Center at Harper for math.
- Make sure you list Harper College as the receiving school for your NLN results.
- NLN Scores must be from testing completed after January 1, 2021.

#### **Submit Additional Documentation**

Note: Official documents are those sent directly from the institution to Harper College.

#### ☐ Official High School Transcript OR GED Results

- Submit the final high school transcript with the graduation date posted, or the GED report which must show passing scores to <a href="mailto:processing@harpercollege.edu">processing@harpercollege.edu</a>.
- Applicants who have completed high school in another country need to submit a document-to-document evaluation of their high school transcript completed by Educational Credential Evaluators, INC (ECE) www.ece.org or World Education Services (WES) www.wes.org stating U.S. Equivalence: High school diploma.
- This high school transcript requirement can be waived if official documentation is provided demonstrating completion of the equivalent of a U.S. associate or higher degree.

Official College Transcripts - You will need to submit official transcripts from other colleges attended
if the document(s) show completion of course work you think may fulfill course admission
requirements or support course work applicable to the Harper College Physical Therapist Assistant
Program. Results can be sent to <a href="mailto:processing@harpercollege.edu">processing@harpercollege.edu</a> .

- Requests can be made at the institution website or https://www.studentclearinghouse.org/students/.
- Foreign college transcripts must first be evaluated by World Education Services (wes.org) or Educational Credential Evaluators, INC (ece.org).
- To learn if/how credits from other colleges will transfer to Harper, applicants must have an official transcript sent from each college or university attended. Official transcripts will be evaluated after they have been received and students will be sent an email to their **Harper email account** with transfer credit information.

## **Program Prerequisites**

### Must be completed by the end of the semester in which the deadline falls

	• Current or previously enrolled Harper students must have a minimum 2.0 grade point average.
	English Composition - ENG 101- Composition at Harper College, or the equivalent from another college (as determined by the Harper College transcript evaluation).  • Must be completed with a grade of C or better.  • There is no expiration date on ENG 101.
	Human Anatomy - BIO 260 (previously 160) – Human Anatomy at Harper College, or the equivalent from another college (as determined by the Harper College transcript evaluation).  • Must be completed with a grade of C or better.  • Five-year time limit on BIO 260. Refer to the chart on the following page for expiration dates.
	Medical Terminology – HSC 112 - Medical Terminology at Harper College, or the equivalent from another college (as determined by the Harper College transcript evaluation).  Must be completed with a grade of C or better.  There is no expiration date on HSC 112.
ć	<ul> <li>Mathematics – MTH 101, MTH 103 (recommended) or higher-level math, or the equivalent from another college (as determined by the Harper College transcript evaluation).</li> <li>Any course used to satisfy the mathematics course requirement must be completed with a grade of C or better.</li> <li>There is no expiration date on the MTH course requirement.</li> </ul>
	Speech – SPE 101 – Fundamentals of Speech Communication at Harper College, or the equivalent from another college (as determined by the Harper College transcript evaluation).  • Must be completed with a grade of C or better  • There is no expiration date SPE 101.
]	<ul> <li>Re-entry Permission</li> <li>If you were previously enrolled in the program to which you are planning to apply, departmental permission is required for re-entry. Without department approval, your file remains incomplete.</li> </ul>

BIO 260 – HUMAN ANATOMY (was 160)	Must be completed after January 1, 2019
BIO 261 – HUMAN PHYSIOLOGY* (was 161)	Must be completed after January 1, 2019

<sup>\*</sup> Although BIO 261 (previously 161) – Human Physiology - is not an admission requirement, if taken, it must follow the timeline for expiration.

#### **Admission Decisions**

PLEASE NOTE: Satisfaction of admission does not guarantee acceptance.

Ranking scores will be calculated based on a point system with a maximum of 100 points; no
points will be added to an admission score for coursework completed after the application
deadline. You can calculate your ranking score based on the following chart:

<sup>\*</sup>BIO 261 (previously 161) is not required for admission; however, applicants who have completed this course with a grade of C or better within the five-year time limit and before admission decisions are made will earn additional points as indicated above.

#### **Early Admission Option:**

Applicants whose files are complete upon application may qualify for Early Admission. If qualified, we will send notification of acceptance to the email address provided on the application and to your Harper College email. To be eligible for this option, applicants must meet specific conditions as follows:

- Applicant must be a resident of Harper's district or a community college district which does not offer a
  Physical Therapist Assistant degree program and whose college district is a member of the CAREER
  consortium; and
- The file must be complete—all academic and document requirements must be satisfied; and
- The ranking score must be 80 or higher, and
- The applicant must meet all admission requirements by January 15, 2024 and seats must be available.

There are 10 seats available for <u>Early Admission</u>. Once the 10 seats are filled, and/or any applications received after January 15, 2024, as well as any applications that do not meet all four of the above conditions, will be considered under the Standard Admission Option. There will be no exceptions to the above criteria.

- <u>Standard Admission Option</u>: (For seats remaining following Early Admission)
  The files of all applicants who have submitted their applications by the program deadline (and who were not already accepted through Early Admission) will be reviewed by the Admission Selection Committee.
- This file review meeting will be held as soon as possible following the program deadline.

<sup>\*\*</sup> A Bachelor's Degree is not required; however, 10 points will be given with proof of an official transcript from the degree-awarding institution

- A "final" minimum admission score will be determined, and those applicants whose ranking scores are at or above that minimum will be considered for admission or the alternate list.
- Admission cannot be guaranteed, and will depend upon ranking score, residency, and number of seats available.
- If there are more qualified applicants than space available, residency may be a factor in the Standard Admission process.
  - ° Permanent residents and residents of community college districts which do not offer a Physical Therapist Assistant program **and** whose college districts are members of the CAREER consortium, who have satisfied the minimum admission score and applied by the application deadline will receive priority consideration in the Standard Admission process.
  - Residency is determined by the Registrar's Office; the address on record with the College as of the program deadline will be used by the admission selection committee when they determine admission decisions. Working in district does not constitute residency for limited enrollment selection purposes.
- Provided a program is open past the published deadline, a qualified applicant who submits an
  application after that date will be considered after all qualified applicants who applied by
  deadline. Applications will continue to be accepted until the program is closed. Check the web
  site for information on the application status.
- It is not possible to predict what ranking score an applicant will need in order to be accepted into a limited enrollment program. However, NLN scores in the 80's and 90's and A's and B's in BIO 260 (previously 160) and HSC 112 make applicants more competitive in the selection process.

  Satisfaction of minimum admission requirements does not guarantee acceptance.

## **Important Admission Notes**

- It is the applicant's responsibility to ensure that requirements are met and all documentation is on file.
- Academic admission requirements must be met by the end of the semester in which the deadline falls.
- Accepted applicants must be 18 years of age before the program starts.
- All correspondence regarding your limited enrollment application will be emailed to the address given on your application, or according to your email address on record with the College.
   Additional correspondence from the program coordinator will be sent to the email address you have provided. It is your responsibility to see that your address information is current. To update your addresses (and/or phone number), you will need to contact the One Stop Center, Building A, Room A250. (The address on record with the College as of the program deadline will be used by the admission selection committee when they determine admission decisions.)
- Applicants should be aware that it may take up to three weeks for the College to receive transcript(s) from the sending institution(s). Official transcripts will be evaluated as they are received, and students will receive an email to their Harper email account when they have been evaluated. Results can be viewed online through the student portal. Transcript evaluations may take 2–3 weeks to process. Questions about transcript evaluations can be sent to evaluation@harpercollege.edu.
- Applicants not accepted into a program who wish to be considered in the selection process for a future term **must submit a new program application.**
- Once your program application has been processed, you will be able to monitor your limited enrollment file online. Go to harpercollege.edu and log into your MyHarper Student Portal; limited enrollment information can be found under the Registration and Records section.
- Qualified applicants not selected may be identified as alternates. Alternate lists do not carry
  over from one application cycle to the next; therefore, alternates who are not admitted to a
  program will need to submit a new program application for a future program start.

- It is very important that you make financial aid preparations well in advance of any deadlines so that you know exactly what resources are available to you.
- Depending on the number of qualified applicants eligible for admission when admission decisions are made, it is possible that contingency offers may be extended to applicants who are in the process of completing an admission requirement (except for the NLN percentile minimums, which must be satisfied in order to submit a program application). When/If contingency offers are extended, the contingent requirement(s) must be satisfied within the semester in which the deadline falls. If the contingency is not met by the given date, the offer will be rescinded.
