DISCUSSION OF FOLLOW UP ITEMS	Laura Brown sat in for Dr. Ender as he was off campus and participating in the meeting by phone.
	Coy presented the results of the Personal Assessment of the College Environment (PACE) survey, which had an overall 47% response rate. Ratings were in the consultative $(3.00 - 3.99)$ and collaborative $(4.0 - 5.0)$ ranges, with the overall climate rating being high consultative (3.70) . These results are similar to the PACE norm base for large two-year institutions. Harper's student focus rated consistently highest among factors, while mean ratingc for all factors declined slightly over time.

	Schlenbecker presented the Strategic Plan Update, which was informed by the recent Achieving the Dream (AtD) coaches visit. Their recommendations were around focus and alignment, which helped make some connections between existing initiatives. She reviewed the Strategic Plan dashboard for 2016-2019; all items are in progress and on target, with targets only just being set.
	Bonnstetter reviewed the FY17 budget to date. There is still a risk that Harper will be responsible for MAP grants this year.
	Dr. Ender and Smith discussed the current status of the potential Pearson collaboration for specific online programs.
	Brown reviewed the Board Packet.
