# STUDENT TRUSTEE REPORT

Student Member DeBold gave his final report. He thanked the Board for a last opportunity to speak. In an initial note, he acknowledged the unfortunate passing of a Wheaton College student, and the passing of two Harper College students in a recent auto accident. He extended condolences to the families and the communities that have been affected by these tragic losses.

This year's speech team finished 6<sup>th</sup> place at Nationals out of 59 community colleges. The Harper team won gold in 3 out of 13 speaking events, and 22 team members competed. Earlier this season, Harper placed 2<sup>nd</sup> in the State Championships and Gold in the Regional Championship. He thanked the coaching staff, Jeff Przybylo, Margaret Bilos, and Josh Sunderbruch.

The Black Student Union conducted the Students of Success mentoring program for the second year in a row; this year they visited Palatine High School. They lead sessions, activities, and discussions about college, starting college, and college experiences.

Student Appreciation Day was hosted by Student Activities on April 20. More than a thousand students participated in the event, enjoying personal pizzas, Harper giveaways, and a 70 foot obstacle course near Building J.

The Center for Student Involvement held two recent events: Student Aide Appreciation Luncheon and a showing of the movie *Life Animated*. The movie was co-sponsored by Access and Disabilities Services for Autism Awareness Month. The next big event will be the Celebration of Excellence on May 5 in the Harper Performing Arts Center. There will be more than 25 award recipients and student performances will be featured.

Student elections were held earlier this month. Niki Safakas was elected the next student trustee. SGA officers elected for the 2017-2018 academic year are President Sulayman Qazi and Vice President Christine Hanna.

Student Trustee DeBold ended his comments by reaffirming his belief that College officials and advocates will continue to focus on improvements for the school, students and the community. He asked that the Board carefully consider construction projects and their associated operating costs to ensure they are scaled properly and that they do not put undue burden on the taxpayers or students.

He thanked the Board for the opportunities and experiences that he experienced. He mentioned learning many things and being thankful for sitting in on important meetings and having the freedom to ask questions and voice opinions even if they differed with that of College leadership. He expressed his confidence in the new Student Trustee who will work for the betterment of students.

Chair Dowell asked Member Kelley to read the following resolution recognizing Student Member DeBold. Member Kelley read the resolution and presented the framed resolution to Student Member DeBold.

# FACULTY SENATE PRESIDENT'S REPORT

Faculty Senate President Dowd shared that it has been his pleasure to serve the Faculty as Faculty Senate President for the last nine years. He introduced the newly elected Senate Executive Board: President David Richmond, Vice President Lisa Smith, Secretary Jeannine Lombardi, Grievance Officer Bobby Summers, and Treasurer Andy Kidwell.

Dr. Ender, on behalf of the administration, thanked Dr. Dowd for his hard work on behalf of the faculty and the institution. He remembered Dr. Dowd serving as a member of the Presidential Search Committee and discovered the two would be able to work well together and understood each other. Dr. Ender noted it is absolutely fitting that the faculty nominated Dr. Dowd for the

Distinguished Faculty Member of the Year award, for which he was selected. This not only acknowledges the work Dr. Dowd does every day in the Chemistry Department with students and in the lab, and the leadership he provides his department, but also the great work he provides to Harper. He congratulated and thanked Dr. Dowd on behalf of the College.

Faculty Senate President Richmond introduced himself to the Board and stated that he looks forward to the opportunity to work with them over the next several years. He thanked Dr. Dowd for his service and added to Dr. Ender's comments that Dr. Dowd was the longest serving Faculty Senate President in Harper's history, and that his legacy is strong. Dr. Dowd will still be serving as a member of the Faculty Senate Executive Committee. He stated that the Faculty Senate Executive Committee, the Faculty Senate, and the faculty-at-large thank the Board for all they do for the College and look forward to working together in the next three years.

#### PRESIDENT'S REPORT

Dr. Ender noted that the busy season of honorific celebrations has just begun. One of those celebrations was the Phi Theta Kappa Induction Ceremony held April 12 and another is the Honors Convocation coming up in May. Tonight's Student Success Report is an overview of Harper's Honors Program and Phi Theta Kappa Chapter. He asked Darice Trout, Associate Dean of Interdisciplinary Programs to introduce this presentation.

Student Success Report Honors Program and Phi Theta Kappa

Trout thanked the Board for the opportunity to share information about Phi Theta Kappa and the Honors Program at Harper. She introduced the Honors Program Coordinators and Phi Theta Kappa (PTK) advisers to talk about these programs, Drs. John Garcia and Alicia Tomasian, along with two Honors Phi Theta Kappa students, Walli Rizvi and Faustus Udrenaj.

Dr. Garcia explained that Phi Theta Kappa and the Honors Program function as a unit when it comes to the extra-curricular activities in which they engage. The difference between the two is that the Honors Program gives students access to the Honors courses here at Harper College, whereas Phi Theta Kappa gives students access to the national network. Phi Theta Kappa is the official honors society of two-year colleges. The Honors Program admitted 182 members over the past year, of which 126 students participated in Honors courses this spring. In addition, Harper College's Phi Phi Chapter of Phi Theta Kappa inducted 370 new members this year.

One of the things Phi Theta Kappa and the Honors Program do together is community engagement. Service hours are not a requirement, yet members performed more than 300 hours of community service this year. Opportunities include Lydia Home,

Habitat for Humanity, Inspiration Café, Elgin Crisis Center, Special Olympics, and Feed My Starving Children.

Dr. Tomasian explained that Harper usually has two big cultural outings a year with about 40 and 50 students participating. Cultural Experience opportunities include the Chicago Shakespeare Theater, Lyric Opera of Chicago, Steppenwolf Theatre, Raven Theatre, Holocaust Museum, Field Museum, and Harper productions. In addition, the annual Honors Variety Show is produced every spring. Currently, academic lectures are included where students attended a lecture on the rise of Isis this past fall.

Another important part of the Honors program is student research and presentations of their research at conferences to train them to be scholars. We know that for students who are interested in going into graduate programs, it's important that they have original research before they attempt to apply. Community colleges are a great place to do this research where they get individual attention. Every year, a number of students attend the Honors Council of the Illinois Region where they present their original research. Last year four students participated in the National Collegiate Honors Council which was in Chicago, where one of the students here tonight presented a paper on Chicago and Pakistani identity. Three members recently attended the International Phi Theta Kappa Conference in Nashville. They attended many sessions on various topics such as how to plan projects and how to organize the chapter. Harper student Walli Rizvi was awarded a Guistwhite Scholarship at this conference.

Dr. Garcia explained that Walli Rizvi is also the recipient of a Jack Kent Cooke Foundation Transfer Scholarship, which is a full ride scholarship to wherever he chooses to transfer and covers up to three years of education. There were only 55 of these awarded this year in the country of which three are in Illinois. Walli represents the ninth Harper recipient over the last seven years. There was only one year in the past seven years that Harper did not have a winner. He took a moment to recognize Professor Tomasian's work with these students. One Illinois scholarship for Harper students is the Honors Program full-ride scholarship to Elmhurst College. There is also a preferred admissions agreement with Georgetown University. Phi Theta Kappa is known for the hundreds of thousands of dollars in transfer scholarships that are available and that our students make use of every year, and many of these come to students automatically for being in the organization. Professor Tomasian has worked closely with the students on essay writing workshops, has brought transfer coordinators to campus, held an Honors and Phi Theta Kappa transfer fair, and arranged campus visits. Recently students visited Lake Forest College and Elmhurst College to get a sense

of what a very small and a midsized suburban liberal arts college feels like. Harper students have transferred to colleges like Columbia University, Bryn Mawr College, Georgetown University and Stanford University. Sometimes we have distinguished alumni who are now working for the college, like Stuart Templeton who was a member of the program years ago.

Dr. Garcia invited Walli Rizvi and Faustus Udrenaj to share their experiences in these programs.

Rizvi stated that students really do feel a sense of community in Honors and Phi Theta Kappa, especially a student like him who is an international student whose family is in Pakistan. Part of this is due to the weekly meetings and small class sizes, but most of it is due to the easily approachable professors. Additionally, the Honors Program provides a lot of room to grow and for people to become leaders and scholars. This has provided a lot of motivation to succeed and do your best. Rizvi explained that he is very thankful that Harper has a successful Honors Program and Phi Theta Kappa chapter.

Udrenaj shared that this is his first year at Harper and as the secretary of the Phi Theta Kappa Phi Phi Chapter he hopes to make Phi Theta Kappa more than just an opportunity for scholarships, but more about community involvement. There are plans to do an "Honors in Action Project" that is international. Many Phi Theta Kappa local chapters do this and it creates an image that Phi Theta Kappa is more than just about scholarships. It's really about the community we can create.

Dr. Tomasian took a moment to invite the Board to the Honors Convocation on May 9.

Dr. Ender thanked the presenters and congratulated the students. He thanked Dr. Tomasian in particular for the hours of work she puts in with the students on the Jack Kent Cooke applications.

Dr. Ender continued the President's Report sharing that he recently attended meetings with the President's Council in Springfield and as a board member with the Illinois Manufacturing Association. Both meetings centered on the State budget issues. The current State budget expectations begin with the recently passed House budget, which was passed as a lifeline budget. It only budgets \$35 million for community colleges as opposed to the expected \$85 million, but includes some MAP funding. This now goes to the Senate where some minor tweaks are expected, including a small increase for community colleges, and they expect it will pass. The House and Senate expect that they will resolve their differences between their bills and that the budget will find its way to the Governor's desk where it is expected that he

will promptly veto it. From the conversations at these meeting, it does not seem at all unrealistic to expect that the College will not see any more money for FY17 and none in an FY18 budget. It would be better to just know that there will be no funds forthcoming instead of this ongoing state of ambiguity. The good news is that the College is going to end this fiscal year with a balanced budget and maybe even a slight surplus. That is a result of the actions that Harper took a year and a half ago. Early retirements of our faculty are beginning to make a difference on the revenue side of our budget and there's been some terrific work done by our managers and supervisors to hold their expenses on lines that are discretionary which has helped us a great deal. This is commendable.

Planning for graduation is underway; it will be this president's 19<sup>th</sup> consecutive rain-free graduation. We are looking forward to former Secretary of Education Arne Duncan joining us on graduation day. President Obama's office in Washington D.C. has replied to an invitation to serve as our 2018 graduation speaker which represents Harper's 50<sup>th</sup> graduation ceremony. We were informed that our request is in the cue and hopefully schedules will work out. It is a plus that we were not rejected and are still under consideration. There are many reasons Mr. Obama may want to come to Harper College given the agenda he had in his presidency and all the work the College has done around his completion agenda. It is a long shot, as the saying articulate: If you don't ask, you won't be considered. We remain hopeful that he will accept our invitation.

Patrick Bauer was acknowledged for his work with the Harper Water Polo Team which won the national championship tournament over some large universities. They will be attending the May Board meeting. He concluded his report.

Board Committee and Liaison Reports

ICCTA Liaison Report: Member Kelley reported he was unable to attend ICCTA Lobby Day due to an injury. He did have the privilege of attending the AACC conference this past weekend in New Orleans. The focus of the conference was on student success, student completion initiatives, and there were some incredibly impressive results being generated from advising, early alerts, and pathways initiatives. He was impressed with the data showing the effectiveness of efforts like smart phone early alerts and predictive analytics to flag students who haven't registered or submitted their FAFSA. These are things that Harper has invested in and is bringing to scale.

Foundation Liaison Report: Member Hill made a point of letting the Board know that a Memorandum of Understanding (MOU) between the Board and the Foundation Board has been approved by the Foundation. A small committee made up of Foundation Directors Kathy Gilmer and Georgeanna Mehr along with herself and Nancy Robb, met to review and make recommendations for updates to the MOU. The current MOU has been in place since 2011, and it is best practice to review these every few years. The MOU helps to clarify shared visions, relationships, and functions of each entity. The Harper College Educational Foundation was established in 1973 (44 years ago). Since this time, the Foundation has raised \$30,426,019 (1973-2016) from 9,221 individual donors. The updated MOU will be sent for Board review and approval at the May meeting.

On Saturday, April 29, the Foundation will be hosting the 3<sup>rd</sup> annual "Realizing Dreams" breakfast. The title of this event reflects the role donors of the Educational Foundation play in the lives of Harper students. Through the generosity of the donors, students feel the importance of their education and their ability to realize their dreams. At this event you truly feel the student's gratitude to their donors and the scholarships they received.
