Alumni Spotlight: *Yoshiko Urayama*



Yoshiko Urayama relocated to the U.S. in 1988. During that same year she began taking classes at Harper College as a way to improve her language skills. Proud of her years of study at Harper Yoshiko shared the importance and value of education she received at Harper College. Today Yoshiko is the seventh president and editor of the Chicago Shimpo Newspaper. The Chicago Shimpo is a weekly Japanese newspaper that began publishing on November 15, 1945, and has a circulation of 5,000. It covers national, international, and local news in Japanese and English.

Can you tell us about your time at Harper College and why you came to Harper College?

I came to Arlington Heights for the first time on June 12, in 1988 due to my husband's job. I had studied English in Japan, but I soon recognized that my English wasn't practical in the real English world. A librarian at the Arlington Heights Library recommended me to attend Harper College, so I went to the registration office in August in the same year.

During my time at the college, my reading, writing, speaking, and listening skill all drastically improved. For Japanese, speaking English is especially difficult. I appreciate Mr. Peter (I cannot remember his last name) at the accounting tutoring center asking me to become an accounting tutor. I could improve my speaking skills while I explained Accounting 101 and 102 to some students.

I still remember that I struggled to follow an American Literature class. I took the class in summer just after I had finished ESL courses. We had to read 10 novels in eight weeks. I thought about dropping out, but with the teacher's encouragement, I finished the class with a "B."

After taking the Literature class, my reading speed improved so much. That experience led me to take many different courses at Harper College.

Harper College also provided me opportunities to meet people from different countries. It was a precious experience for me to know "diversity" which I never experienced in Japan.

How did Harper College help you in your profession today?

When an opportunity came to me to take over the Chicago Shimpo, I knew about business management, accounting, fundamental law, computer software to

Motorola Distinguished Faculty Award

The Motorola Distinguished Faculty Award committee is comprised of a member of the Board of Trustees, four previous award recipients, an administrator and a student. The committee is chaired by the Assistant Provost. On April 18 the committee met and recommended **Dr. Catherine Restovich, Associate Professor of English**, as the 2011 Motorola Distinguished Faculty Award recipient.

Dr. Restovich consistently strives for excellence in all she does. And, for the past 11 years at Harper College, excellence is what she has brought to her classroom and shared with her students. Dr. Restovich possesses the unique ability of challenging, inspiring and motivating her students to achieve at higher levels of learning. She has taught 13 different courses for the English department - four of which she created with a colleague in the history department.

Dr. Restovich believes her job is to treat students with dignity and to guide them to treat others with dignity. Through focusing on civil rights and social justice in her classes, she works to help mold students into critical thinkers and advocates for others.

Over the years, she has been a faculty leader in many areas at Harper. She currently serves on the master planning committee, on the learning communities committee and is working to create success cohorts for developmental students. She has also served as English department chair and has presented at the campus, local and national level.

Committed to teaching outside the classroom as well, Dr. Restovich is a dedicated volunteer through her work at Ronald McDonald House, the House of Hope, the Dorothy Day organization and her support of the Red Cross and numerous Catholic Charity groups. She also serves as a mentor to her students for issues outside of the classroom and is recognized by her students as a caring, empathetic and kind person.

In a letter to the Dean of Liberal Arts, nominating Dr. Restovich for the award, a faculty colleague said of her:

"Dr. Restovich is the most effective teacher of any colleague in my 27 years of teaching. Her combination of scholarship and passion for the art of teaching provides an ideal definition of the spirit recognized in the Distinguished Faculty Award."

Board Member Spotlight: *Jerome (Jay) Fritz*



Jay Fritz is a lifelong Chicagoan who resides in Inverness with his wife, Karen. Fritz received his Bachelor of Arts from Loyola University and MBA from DePaul University, with a focus in finance.

He began a long career in banking at Bank of America (formerly Continental Illinois National Bank) with a focus on commercial lending to middle market corporations based in the Midwest. Fritz continued his banking profession with Community Bank in Libertyville, Northern Trust and First National Bank of Chicago.

In 1991 he formed Royal American Corporation with the support of local investors. For the next 15 years under the leadership of Fritz as Chairman and CEO, Royal American Bank grew to over \$550 million in banking assets with an additional \$100 million in managed customer accounts in its Trust Department and Broker/Dealer subsidiary. In 2006, Royal American was sold to a public company, Midwest Banc Holdings, Inc., for \$135 million in cash and stock.

Following the acquisition by MBHI, Fritz continued to serve as President and COO of Midwest Bank, and EVP/Board Member of its parent holding company until 2010. At that time the bank was sold to FirstMerit Bank, Akron, Ohio through an FDIC assisted transaction.

He joined Cornerstone National Bank & Trust in 2010, along with a team of senior bankers he had been associated with at Royal American Bank. Fritz is currently Managing Director and a member of the Executive Management Committee at Cornerstone, an organization committed to serving its community and closely held businesses throughout metropolitan Chicago.

Throughout his career, Fritz has remained actively involved in many charitable and civic organizations including the Wellness Place, Buehler YMCA, WINGS, the Northwest Suburban Chamber of Commerce, Northwest Community Hospital and the Inverness Association. He has also supported Harper College through their scholarship fund, and he served as an adjunct faculty. ■

make paper layouts, how to use Photoshop, how to see art work, and more. All of my knowledge came from my eight years of study at Harper College.

I have so many memories at Harper. My smoking spot was outside of the building L where I met many people and enjoyed small takings. ■

Motorola Solutions Partnership Promotes Student Success

When Brenda Escutia mentioned her dream of becoming a nurse, people sometimes discouraged it, saying it was too hard.

The Rolling Meadows resident didn't let the dream go, enrolling this summer in a Harper College program aimed at helping incoming freshmen, Escutia among them, succeed in college and the professional world that comes afterward.

Through the Choice Scholars Institute, she brushed up on math, reading and writing skills while jumpstarting her healthcare studies; thanks to a new partnership with Motorola Solutions, Inc., she also received career tips and encouraging words from Motorola Solutions professionals who talked with students about their jobs, the attributes bosses look for in potential employees, and the importance of determination and being willing to learn new things.

“When people say, ‘You can do it. I was in your shoes,’ it really encourages you,” Escutia said. “Now I see that if you’re really interested and you really want to do it, you’re going to go the extra step to be successful.”

Escutia left the program more inspired than ever to pursue a career in nursing.

The four-week Choice Scholars Institute was launched three years ago, and targets new students whose placement tests land them in at least one developmental course, but whose scores also put them on the cusp of college-level classes. About three dozen students enrolled this year, brushing up on basic skills within the context

of career paths that interested them, like healthcare, chemistry and graphic arts. Through this year's “Motorola Moments” lunchtime sessions, they also took home workplace advice from Motorola Solutions professionals, who covered everything from critical thinking, innovation and marketing to communications, teamwork and the importance of a positive attitude.

“This program is an outstanding example

of the many ways in which we're really connecting the dots for our students,” Harper College President Dr. Kenneth Ender said. “Through this program and specifically our partnership with Motorola Solutions, we're teaching students the things they need to know to succeed at William Rainey Harper College and in the workplace. It's exciting for these students, and it's inspiring to us to see the potential they have to grow and achieve.”

The program's kickoff Motorola Moments session focused on career preparation and the job interview process. In a later session specifically tailored to Choice students interested in graphic arts, Motorola Solutions professionals outlined the company's approach to marketing campaigns and answered questions from students about brand messaging. A wrap-up session focused on workplace etiquette and common mistakes people make that can trip them up professionally.

“This partnership is devoted to providing freshmen with the fundamental skills they need to thrive in an educational setting and in a professional setting,” said Marianne Stanke, Director of Staff Operations at Motorola Solutions, Inc. “We are committed to jointly guiding students to be better-equipped, and making America more competitive on a global level.”

Program participants have been able to improve their test scores and begin college-level coursework earlier. Research shows the longer students remain in developmental courses, the less chance they have of graduating from college.

The Choice Scholars Institute is part of Harper's new Student Success Agenda, designed to help more students graduate with a degree or workforce certificate or transfer successfully to a four-year college or university. The Motorola Solutions partnership grew out of Skills for America's Future, aimed at bolstering industry partnerships with community colleges and building a national framework to maximize workforce development strategies, job training programs and job placements. ■

Gifts of Life Insurance

Life insurance. At first blush the thought of it may not exactly send shivers of excitement down your spine. However, if you have a sincere desire to make a major financial contribution in support of future Harper students, life insurance can be an excellent tool for helping to accomplish your philanthropic and other financial objectives. Indeed, life insurance can empower many individuals to make charitable gifts they would never have dreamed possible - and at a relatively modest after-tax cost to the donor.

Gifts of life insurance can be made as easily as just naming the Harper College Educational Foundation as a beneficiary. While no immediate tax benefits are available, identifying your charity of choice as beneficiary only requires the submission of a new beneficiary form and results in no out-of-pocket cost.

If you anticipate the policy will not be needed at your death, another option is to assign ownership of the policy to the Educational Foundation resulting in some immediate tax benefits. By assigning complete and outright ownership of your life insurance policy, you are making a gift in the policy's payout amount at your death with no out-of-pocket cost. And, you can deduct your cost basis or interpolated terminal reserve value (whichever is less) from your Federal income taxes in the year of the assignment. A professional advisor (CPA, estate attorney, and/or financial advisor) will be able to assist you in assessing your deduction amount. Furthermore, you can arrange to deduct any future premiums that may be due on your policy by gifting them to the Foundation annually. If you are interested in exploring gifting in this manner, we ask that you work the Foundation and a professional advisor who is versed in charitable gifting to assist you through this process.

Finally, if you are strongly motivated to make a significant gift to charity, but constrained from doing so by family considerations of providing an inheritance or assets for children and grandchildren, several options exist:

- You can name our institution as the contingent beneficiary. In this case, we will receive the proceeds only if your primary beneficiary is not living at the time of your death.
- You may want to consider a "wealth replacement" technique such as transferring the policy to a charitable remainder trust. The trust will pay an income to your beneficiary for life. At the death of the beneficiary, any remaining proceeds will pass to the Educational Foundation.
- Another wealth replacement technique is to establish an irrevocable life insurance trust, allowing the trust to provide assets to your family without being subject to taxation while donating other taxable assets to charity.

In the final two examples, the rules are technical and every person's financial considerations vary, so we once again recommend you seek help from an advisor who is familiar with charitable gifting in this manner.

Regardless of the gifting method you utilize, the rewards to you, the charity, and your family by seeing your charitable intentions fulfilled in a meaningful way can be very positive.

In Memoriam

Robert Powell

Today's students may have not had the delight of meeting Robert Powell, but his accomplishments are still prevalent today by the many alumni and colleagues he touched.

Although he was always happiest in the classroom teaching English, Robert's students and peers regarded him not just as a teacher but as a mentor. He displayed his leadership and encouragement as president of the Faculty Senate and later as dean of the College of Liberal Arts.

Since his retirement more than 20 years ago, Harper students and colleagues have commented on the significant influence Robert had on all who worked and studied with him. Indeed, he is still considered something of an institution by Harper alumni and faculty alike.

In a recent interview, Robert's longtime friend and founding faculty member Thomas McCabe described Robert's influence. "I would have to

call him an intellectual giant. In the early years he was a natural," McCabe said. "There's no question he was the leader of the pack. His students would come back and say he was the best teacher they ever had. He was the quintessential college professor. When you think of a professor you think of Bob Powell."

Robert will be remembered by his children and grandchildren for his sage advice and knowledge, by his friends for his lifelong love of golf and the St. Louis Cardinals, and by his students, faculty and coworkers both for his love of English and American literature and as a great mentor, professor, intellect and guiding light.

A memorial service was held at Harper College, Room A238 at 11 a.m. on August 26.

As owner of Yopst & Vandersteen C.P.A. Accountants and working full-time Tom Yopst managed to find time to teach and influence Harper College students. He taught for more than 28 years as an adjunct professor in accounting. Recent students commented about Professor Yopst, "Loves to teach and it shows. He is so cool. Show you are trying and he will do his best to help you. Great teacher." Project Awards for Resource for Excellence Grants

For some students, contributions to the Resource for Excellence Fund is what makes it possible for them to pursue post-secondary education in order to contribute in a meaningful way to a 21st century economy while supporting themselves and their families. It also supplies seed funding for innovative programs that emerge from our academic and student activities divisions. These grants have helped to resource new programs deemed to be urgent and relevant to our mission, such as:

The **Career Stimulus** program embraces community members who are un- or underemployed in the current recession to help restore confidence, refine or acquire skills and build networks toward gainful re-employment.

The **Book Bag Literacy Project's** goal is to promote stronger literacy skills in the English as a Second Language (ESL) community Harper serves. Students in the Future Educators Club are creating book bag activity packs. The packs will be circulated to ESL families that utilize the Child Learning Center and the Northeast Center Reading Room. Each book bag pack will consist of one pre-k book in English and one book in the family's native language -

Polish, French, Spanish or Gujarati. CD recordings of the books in English and in the respective language will also be available for circulation.

Another aspect of the project will involve creating book bag packs for children in grades 3-8. The packs will consist of one

book, one professionally read CD in English, a professionally developed discussion guide and developmentally appropriate activities. Parents of children in grades 3-8 will have the opportunity to borrow Kindle audio books to promote self-guided reading activities and further develop English language skills.

This project is a collaboration between the Northeast Center Reading Room, Future Educators Club, Child Learning Center and Academic Enrichment and Language Studies.

The **One Book One Harper** initiative is a collaborative effort to encourage students, faculty and staff to read one book and participate in a variety of academic, cultural and social activities related to the book during the 2011-2012 academic year.

A planning committee representing various departments of the College will review potential titles and make a selection for the campus to read. The books will enable the exploration of diverse perspectives and have multi-disciplinary themes and relevance. The goals of this new initiative are to encourage reading, strengthen connections in the Harper community and increase student use of the campus library and other academic resources.

Choice Scholar Institute is an interdisciplinary and interdivisional initiative to promote college readiness by providing academic enrichment programs for at-risk students, partnering with fellow educators, and introducing students to learn strategies that provide them with a framework

for understanding the challenges and expectation of college and the practical skills need to be successful.

Tech Connect is a project aimed at building technology bridges from students to the College and from students to the community. The project is comprised of two key elements:

Offer CAS 160 to 15 students at the Palatine Opportunity Center. The target students will be adult education students enrolled in Harper's Adult Basic Education/ GED courses who have indicated the intent to transition to credit courses leading to a certificate or degree.

Part two, students will complete a service learning component where they will volunteer to help adults with basic computer and Word skills at the Palatine Opportunity Center.

Implementation of Tech Connect will thus provide students with the means to strengthen their connection to Harper College and also strengthen their commitment to community involvement.

College Access for Special Populations (Year Two) will continue to provide financial assistance with tuition, textbooks and fees for displaced homemakers, single parents, non-traditional career seekers and individuals with limited English proficiency who are living below the Self-Sufficiency Standard for the northern suburbs of Cook County and are unable to secure financial aid.

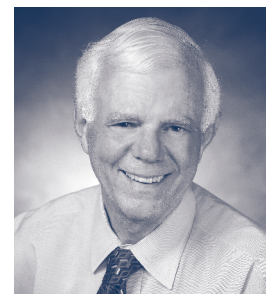

Dr. Nancy Castle was 16 years old and new to northwest Illinois when she arrived at Harper College in 1973. During her time on campus, she explored an interest in psychology and built a foundation of skills and confidence that she eventually parlayed into a nationally recognized career in the field. Castle continued her education at Northern Illinois University, where she earned a bachelor's and a master's degree in psychology and a Ph.D. in clinical psychology.

Over 30 years Castle built a distinguished career, first as a faculty member at the University of Arkansas, and for the last 20, as a professor at Northern Illinois University. She is considered a national expert on the

Her interest in civic engagement has also resulted in her appointment as the campus liaison for service learning.
