Planned Giving: The Gift That Continues Giving



Katherine Sawyer, Associate Executive Director of the Harper College Educational Foundation and Director of Major Gifts shares some insight on charitable planned giving.

What plans have you made for 2011? With recent changes to the tax laws, I would strongly recommend you take time early in the year to review your estate plan with your professional advisor. While doing so, if life experience has led you to value benefits of education, an opportunity exists to create a legacy through the Harper College Educational Foundation that will impact generations of students to come.

A Charitable Bequest

As you contemplate the people and organizations that have been important in your life, a charitable bequest is a wonderful way to invest in a mission you value without having to part with assets during your lifetime. Including an estate gift for the benefit of the Harper College Educational Foundation is easily accomplished with your professional advisor through a codicil to your will or amendment to your living trust.

Simpler yet is to make the Educational Foundation a partial beneficiary of life insurance, financial or retirement accounts. You can donate a specific amount, a percentage of your estate, or a particular piece of property. The value is generally deductible from the estate of the donor. Bequests are simple and flexible—you can change your mind at any time, should you need to.

Why retirement benefits make excellent charitable gifts

As you contemplate which assets you might use to fulfill charitable intentions, it is important to recognize that some assets carry income tax liability to beneficiaries. These items will produce so-called 'income in respect of a decent' (IRD) and will cost your heirs both income taxes and inheritance taxes. Because of our tax-exempt status, by gifting these types of assets to a charitable organization like the Harper College Educational Foundation, no income taxes or inheritance taxes are paid and 100 percent of the value of these items will benefit the Educational Foundation for the purpose you designate. Another beneficiary might end up with only 20 to 40 cents on the dollar after taxes. What this means is that the federal

percent of your charitable gift. Individual retirement accounts (IRAs) and other retirement assets are easy to leave to charity because you can designate the charity as a beneficiary. You don't have to change your will or trust to make this gift or if you change your mind about the amount or identity of the beneficiary.

Sharing Your Intentions

While the majority of bequest designations are revocable, there are a number of benefits to sharing your intentions with the charitable organization during your lifetime.

The charitable organization can offer sample beguest language to assist you and your professional advisor to ensure the right legal entity is identified in your estate documents - so that your gift is received by the right organization.

Alerting the charity during lifetime also allows you to set up a fund agreement with the organization, detailing your designation intentions. This agreement gives the organization proper direction when the gift is realized. For instance, if you would like your gift to establish an endowed scholarship for students, you can pre-determine the scholarship name, purpose and award criteria through the fund agreement. This document will remain on file with the Educational Foundation until it is matched with your estate gift.

Examples of other IRD, or dual-taxed assets include:

- U.S. savings bonds
- Accounts receivable of a professional or business owner
- Deferred compensation
- Last salary check
- Bonuses and distributions from employee benefit plans
- A partner's distributive share of partnership income up to date of death
- Payments on installment notes such as land sale contracts
- Commercial annuities
- Employee stock options

It's important, from a tax standpoint, for a donor's will to specify that these items are to pass onto a qualified organization. With retirement accounts, a donor can change the beneficiary to a qualified charity. Beneficiary designations are also possible with revocable living trusts that contain IRD.

Educational Foundation Board president, Lane Moyer, answers questions about the role and strategic directions for the upcoming year.

- **0** What is the role of the Educational Foundation Board?
- A The Board has three main areas of responsibility: fundraising, planning and policy development, and building community partnerships.

In the area of fundraising, Board members, along with businesses and individuals in the community, contribute personal time and money to fund scholarships and other College Programs. Board members look to develop relationships with future potential Board members and supporters of the College. In addition, Board members lead and support fundraising campaigns and fundraising events.

In the area of planning and policy development, our Board members determine the mission and goals for the Educational Foundation which ultimately support the goals of the College. Our Board is actively involved in strategic planning for the Foundation and has participated in strategic planning for the College. As part of this role the Board develops policies that ensures accountability to the Foundation's donors and the community.

The third area of responsibility includes community and organizational development which requires the broadening of the Foundation's base of support in the community. Our Board members interact with businesses and citizens in the Northwest Suburbs to bring new contacts, opportunities and needs to the attention of the Foundation. This role also includes training and developing current and new leaders within the Board and our committee structure.

Q We have heard about the college's initiative of Building Community Through Student Success. How has the Educational Foundation Board responded to help meet this initiative?

A Building Community through Student Success is a four point plan to improve the performance of our College and its students. First, the College leadership is seeking to increase the **completion** of our students in degree or certificate programs, with a focus on underperforming student groups. Second, the College leadership wishes to create a culture of innovation, **accountability** and transparency at Harper. Third, the College is looking to engage in **partnerships** to develop programs in existing and emerging career areas that enable students to succeed in a global economy. Finally, the College is seeking to develop programs with educational partners that **inspire** post-secondary education and career readiness as a life goal.

The Foundation is focused on ways to support each of these strategic initiatives through development of resources and partnerships. For example, in support of the objective to inspire students to attend college, the Foundations outreach committee worked with Harper's community relations department to launch a program to invite junior high students to campus to get a taste of what College is about. It is important that students be thinking about college in junior high to begin to aspire to a post-secondary education at a young age. We are particularly focused on students who may be the first person from their family to attend college.

- 0 What do you feel will be the most important role for the Educational Foundation over this next year?
- **A** To define ways we can support each of the College's Four Strategic Directions referred to above. It is our hope to develop a three year plan that serves as a roadmap to work together support the four point mission of the College.

Why did you choose Harper College Educational Foundation for you community involvement?

A I absolutely believe that deep down people want to make a difference with their lives. We do this through our families, at our work place and in our community. When contributing to the community, people typically want to maximize the value and impact generated by their time and resources. Supporting the Harper College Educational Foundation is a great way to maximize one's contributions in two ways. First, we are impacting, in many cases. young adults. When a person helps a child or young adult, the payback is multiplied over many years. The ripple effect that a young adult can have in improving the lives of others over 40 to 50 years is tremendous. Second, I know of no greater way to improve a person's life than through education. I did not attend Harper, but I know that the moneys provided to Harper students through the Foundation can make the difference between a person attending college and not attending college.

Senate approves IRA Tax Break for Charitable Gifts

IRA Charitable Rollover was reinstated for 2010-2011 allowing tax breaks for people who use money from their individual retirement accounts to donate to charity.

The legislation also extends tax provisions to encourage donations of property, food inventory, books to public schools, and computer equipment for educational purposes.

Contributions for the 2010 tax year can be made retroactively through January 2011. The IRA Rollover was first enacted in 2006 as part of the Pension Protection Act. The provision allows individuals aged 70½ and older to donate up to \$100,000 from their Individual Retirement Accounts (IRAs) to public charities without having to count the distributions as taxable income.


